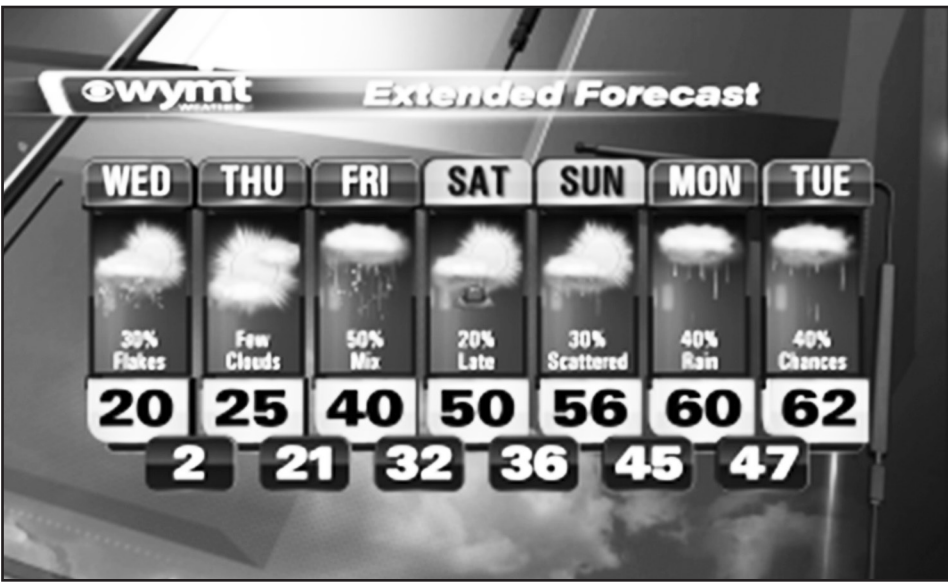


# WYMT News

### District Court News

**Judge Hon. Allen B. Roberts 01-28-19**

Counts 1-6: Not guilty plea. Appoint DPA. Pretrial suspend operators license due to alleged refusal. Pretrial conference: 2-11-2019.

Johnson, Andrew-No/Expired registration plates-Dismissed with proof; No/Expired Kentucky registration receipt-Dismissed with proof; Failure of owner to maintain required insurance/security 1st-Dismissed with proof; Failure to produce insurance card-Dismissed with proof; License to be in possession; Poss controlled sub, 1st degree, 1st off (methamphetamine)-Dismissed without prejudice; Drug paraphernalia-buy/possess-Dismissed without prejudice. Waived days; Conflict counsel. Pretrial Conference: 3-11-2019.

Johnson, Chrissey R-Operating on suspended/revoked operators license-Amend to License not in possession. Guilty plea, \$25 fine and court costs, FRD 3-11-2019.
