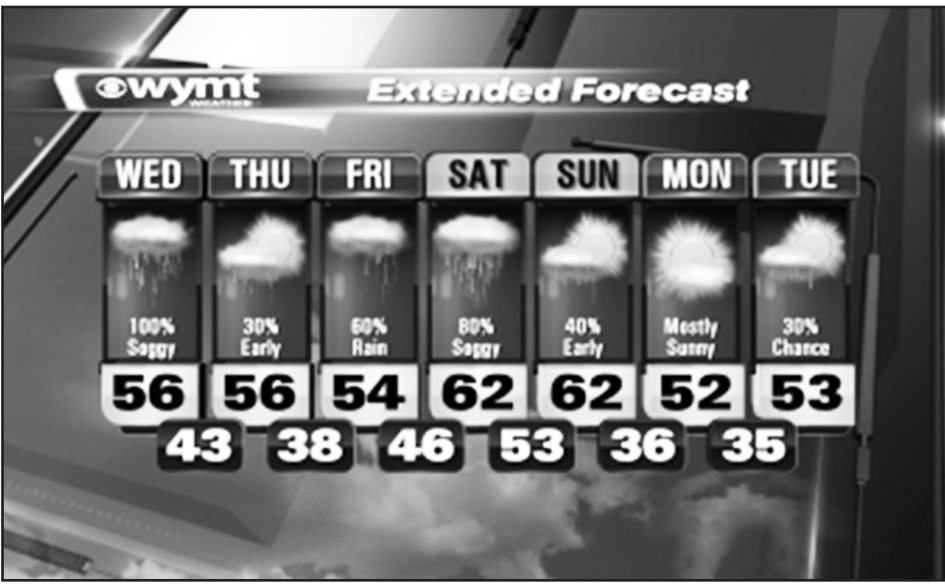

### District Court News
