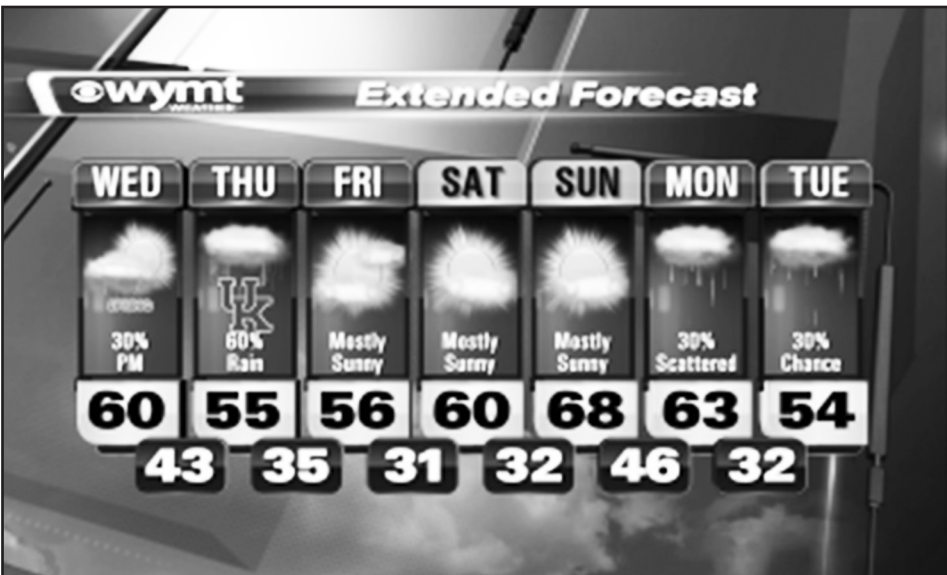

 Hurst Myles Rai-gen-Failure of owner to maintain required insurance/security 1st. Dismissed without prejudice with proof shown.
 Jones, Melissa-No/Expired Kentucky registration receipt; Improper registration plate; Failure to produce insurance card. Counts 1-3: Not guilty plea. Pretrial Conference: 4-29-2019.
 Justice, Cynthia I-No operators/moped

license. Motion to continue by def-no objection by commonwealth. Sent court notice. Continued to 7-22-2019.

Proof of insurance filed on 01/07/19. Continued to 7-11-2019.
 Lunsford, Crystal G-Receiving stolen property u/\$500; Resisting arrest; Menacing; Disorderly conduct, 2nd degree. Jury Trial: 7-11-2019.
 Neace, Sammy Lee-On compliance w/sex offender registration. FTA-BW; No bond.
 Rader, Anthony-Hearing to revoke conditional discharge. Def stipulates that he has not paid restitution. Review: 5-13-2019.
 Ramsey, Wilma-Wanton endangerment 1st degree-Amended to Wanton endangerment 2nd degree; Wanton endangerment 1st degree-Amended to Wanton endangerment 2nd degree. Counts 1 & 2: Guilty plea, Set to 12 days jail, CTS 12 days, Conc. Court finds plea is ki&vol.
 Roaden, Danielle-Public intoxication controlled subs (excludes alc)-Amended Disorderly conduct 2nd degree. Guilty plea, Set to 2 days, CTS 2 days and court costs, 5-13-2019. Court finds plea

is ki&vol.
 Robinson, Allen L-Operating on suspended/revoked operators license. Dismissed without prejudice with proof shown. Proof of ops lic filed.
 Salyers, Jeremy Ryan-Theft by deception-include cold checks \$10,000 or more. In Pulaski Co Jail. Continued to 4-01-2019.
 Smith, Daniel Glenn-TBUT all others \$500 or moer but u/\$10,000-Amended to TBUT all others <\$500 but u/\$10,000. Guilty plea, Set to 60 days, CTS 17 days, 43 CD for 2 years, No contact with Karen and Anthony Smith, Restitution of \$830 at \$25/month beginning 5-01-2019 until paid in full and court costs, 5-13-2019. Court finds plea is ki&vol.

 Tacket, Tara-1st degree possession of cs/opiate, 1st offense; Tampering with physical evidence. Counts 1 & 2: Not guilty plea. Court finds def qualifies and appoints DPA. Preliminary Hearing: 3-25-2019.
 Wilson, Melissa-Public nuisance thru accumulation of rubbish. Dismissed without prejudice with condition of def getting monthly garbage pickup.
 Wilson, Rebecca F-Criminal possession forged instrument-2nd degree-I. Waived days. Def has paid \$600 in restitution so far. Continued to 7-22-2019.
 Anderson, Brent D-Failure to or improper signal; Operating on suspended/revoked operators license; Possessing license when privileges are revoked/sus; Failure to surrender revoked operators license; Failure to produce insurance card; Giving officer false identifying information; Poss controlled sub, 1st degree, 1st off (methamphetamine).

Counts 1-7: Not guilty plea. Def waived days on preliminary hearing. Bond \$5,000 unsecured. Court finds def qualifies and appoints DPA. Preliminary Hearing: 4-15-2019.
