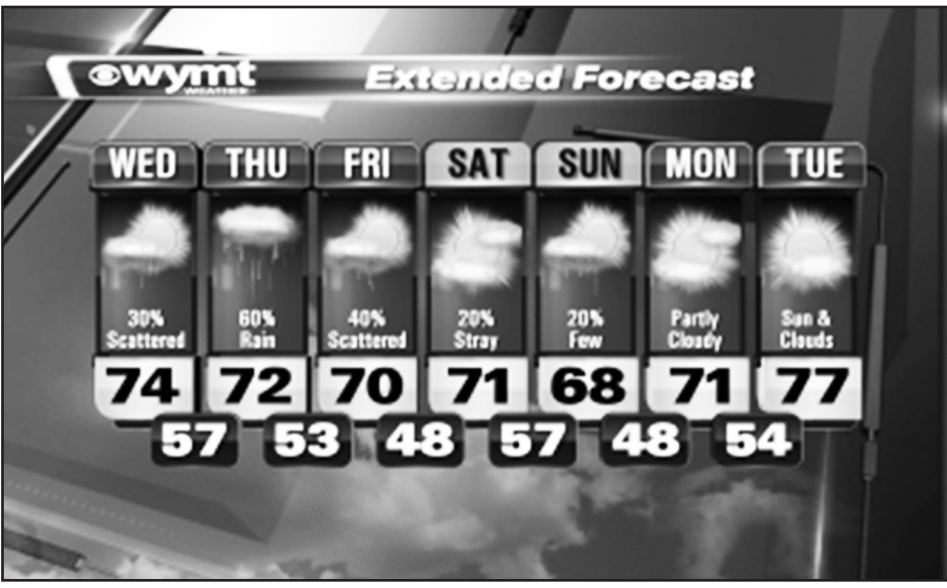

District Court News

Judge Hon. Allen B. Roberts 04-22-19
 Horn, Bradley-Alcohol intoxication in a public place-1st & 2nd; Failure to appear, citation for misdemeanor. Counts 1 & 2: Not guilty plea. Appoint DPA. WOA served for failure to appear at arraignment. 4-29-2019.
 Horn, Larry Bradley-Burglary, 2nd degree; Terroristic threatening, 3rd degree; Violation of Kentucky E.P.O./D.V.O.; Menacing; TBUT or disp auto-under \$500-Amend to TBUT <\$500. Counts 1-5: Not guilty plea. Appoint DPA. Preliminary Hearing: 4-29-2019.
 Lainhart, Sunshine-Poss cont sub, 3rd degree-drug unspecified; Controlled substance prescription not in original container 1st; Failure to appear, citation for misdemeanor. WOA served for failure to appear at court trial. Court Trial: 5-06-2019.
 Barger, Shayla Lynn-Op mv under/influence of alcohol/drugs, etc. .08 1st off; Drug paraphernalia-buy/possess; Poss controlled sub, 1st degree, 1st off (Methamphetamine); Poss cont sub, 2nd degree-drug unspecified; No/Expired registration plates; Failure to produce insurance card; No operators/moped license; Poss of marijuana. The def does waive the preliminary hearing and stipulates to probable cause. Hold case over to Grand Jury for consideration. Recognize defendant to appear in Circuit Court on below date to answer indictment. Send misdemeanor with felony counts; 5-07-2019.
 Carter, Moriah A-Assault, 1st degree-Domestic violence. Not guilty plea. Appoint DPA. Preliminary Hearing: 5-06-2019.
 Cavins, Jeremy-Theft by deception-include cold checks u/\$500. Guilty plea, 90 days jail, CTS 16 days, Balance 74 days, Pay court costs, 6-03-2019.

Connor, Aaron- Assault 4th degree domestic violence minor injury. Dismissed without prejudice. County attorney not able to go forward. Motion to dismissed-Granted.
 Davis, Zackary R-Escape-2nd degree identify facility. Def waives preliminary hearing and stipulates to probable cause. Hold case over to grand jury. Recognize def to appear in circuit court on below date to answer indictment, 5-07-2019.
 Davis, Zackary Tyler-Criminal trespassing-1st degree. Continued by agreement to 5-06-2019.
 Farra, Holly-On DUI counseling. She is enrolled.
 Fox, Harold-No operators/moped license-Guilty plea, \$25 fine and court costs, FRD 6-03-2019; Failure to produce insurance card-Dismissed; Failure to wear seat belts-Dismissed with warning; No/Expired registration plates-Dismissed; No/Expired Kentucky registration receipt-Dismissed. Court finds plea is ki&vol.
 Gabbard, Leslie-Local county ordinance. Send court notice. Continue to 6-03-2019.
 Gambill, Travis-Criminal trespass-1st degree. Not guilty plea. Appoint DPA. Pretrial Conference: 4-29-2019.
 Turner, Gregory S-Failure to wear seat belts. This defendant failed to appear. Send FTA to Dept.
 Harlan, Hope-No/Expired registration plates; No/Expired Kentucky registration receipt; Failure of owner to maintain required insurance/security 1st; Failure to produce insurance card; Operating on suspended/revoked operators license; Failure to wear seat belts. Issue WOA; \$250 cash bond.
 Harrison, Paul Quinton-Op mv under/influence of alcohol/drugs, etc. .08 1st off-Guilty

plea, 6 days jail, CTS 6 days, \$375 service fee and court costs, Suspend license 90 days, Order to attend and complete DUI school; Rear license not illuminated-Dismissed; Failure to produce insurance card-Dismissed; Failure to notify address change to dept of transp-Dismissed.
 Huff, Danielle Alma-TBUT of disp auto-\$500 or more but u/\$10,000-Amend to TBUT under \$500-Guilty plea, 360 days jail, CTS 20 days, Balance CD 2 years per CD; Drug paraphernalia-buy/possess-Dismissed. Court finds plea is ki&vol.
 Hurst, Jackie-Op mv under/influence of alcohol/drugs, etc. .08 1st off; One headlight; No tail lamps. Motion to suppress and motion to dismiss-Granted. Order to be entered. Order bond released.
 Madden, Amy Faye-Assault 4th degree minor injury-Guilty plea, 90 days jail, CTS 33 days, Balance 57 days, CD 2 years; Failure to appear, citation for misdemeanor-Guilty plea, 33 days jail, CTS 33 days. Court finds plea is ki&vol.
 McQueen, Samuel L-Failure to or improper signal-Dismissed; Failure to produce insurance card-Dismissed with proof; Op mv under/influence of alcohol/drugs, etc. .08 1st off-Guilty plea, \$200 fine + \$375 service fee and court costs, Suspend license 60 days, Order to attend and complete DUI school, FRD 6-03-2019. Ops lic pre-trial suspended. Plea agreement. Order bond released. Court finds plea is ki&vol.
 Melton, Dorothy-Public intoxication controlled subs (excludes alc). This defendant failed to appear. Continue to 5-06-2019.
 Moore, Kellie L-No/Expired registration plates; No/Expired Kentucky registration receipt; Improper display of registration plates; Failure to

register transfer of motor vehicle; Failure of owner to maintain required insurance/security 1st; Failure to produce insurance card; Failure to wear seat belts; Failure to appear, citation for misdemeanor. Counts 1-6: Dismissed with proof. Count 7: Dismissed with warning. Count 8: Dismissed without prejudice. WOA served for failure to appear at arraignment; Sent court notice.

Pearson, Jacob R-Failure to appear, citation for misdemeanor; Failure to appear, citation for misdemeanor. (WOA served for FTA at motion to revoke conditional discharge) Continued from 04/08/19. In Rockcastle Jail. Continue to 5-06-2019.
