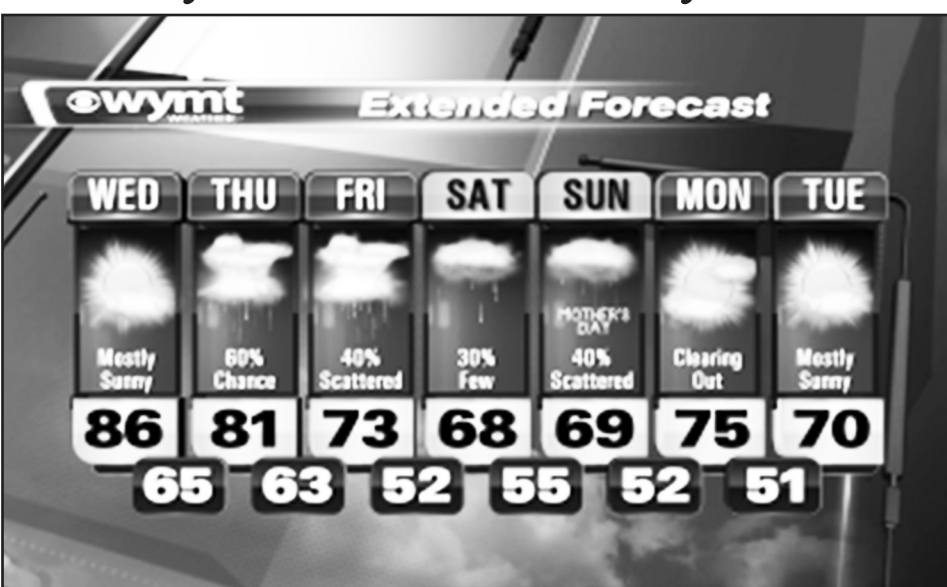

District Court News

Judge Hon. Allen B. Roberts 04-22-19

Baldwin, Jason-No/Expired registration plates; No/Expired Kentucky registration receipt; Failure to produce insurance card; Failure to wear seat belts; Operating on suspended/revoked operators license; Oper mtr veh u/influ alc/drugs/etc. .08 (Agg Circum), 2nd; Failure to or improper signal. Counts 1-7: Not guilty plea. Appoint DPA. Pretrial Conference: 5-20-2019.

Coffey, Donnie Wayne-Violation of Kentucky E.P.O./D.V.O. Not guilty plea. Appoint DPA. Pretrial Conference: 5-20-2019.

Fox, Jobie Austin-TBUT of disp shoplifting u/\$500. Not guilty plea. Appoint DPA. Has active WOA for FTA. Recall WOA. Pretrial Conference: 6-03-2019.

Huber, Travis-Non payment of court costs, fees or fines. Court finds wilful failure to pay not due to inability to pay; 3 days jail, CTS 3 days. WOA served 5-4-19; Failure to pay fine.

Anderson, Brent D-Failure to or improper signal; Operating on suspended/revoked operators license; Failure to wear seat belts; Poss controlled sub, 1st degree, 1st off (Methamphetamine). Def failed to appear. Issue WOA; \$5,000 cash bond.

motor vehicle. Continue by agreement to 6-03-2019.

Hold case over to Grand Jury. Recognize def to appear in Circuit Court on below date to answer indictment, June 4, 2019 at 11:00 am.
