#### Forest Service, Partners Host Kids Fishing Derbies Fees waived at lake boat ramps

WINCHESTER, Ky., May 22, 2017 - In recognition of National Fishing and Boating Week, the Daniel Boone National Forest and partners will host several kids fishing derbies during the first two weekends in June.

In addition to fishing derbies for kids, no fee permit will be required

to use boat ramps outside of developed campgrounds at Cave Run Lake or Laurel River Lake on Saturday, June 3 and Sunday, June 4. Kentucky provides free fishing days each year during the first weekend in June. Residents and nonresidents at any age can fish public waters without a fishing license or trout permit. State creel limits and other

Prior to the fishing derbies, public fishing is will not be permitted at open alcohol beverage derby locations from the day that fish are stocked until the end of the event.
