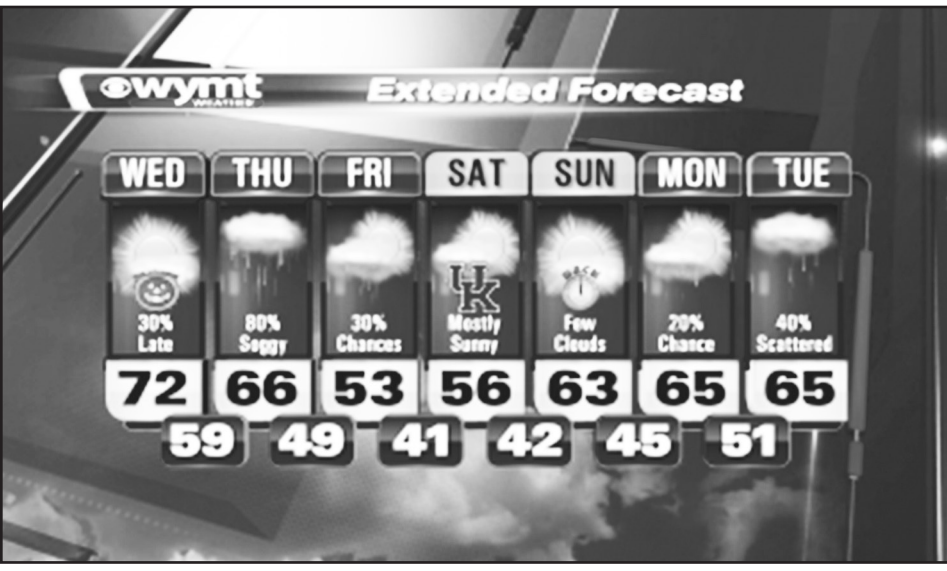


# WYMT News

### District Court News

Judge Hon. Henria Bailey-Lewis 10-29-18

Clemmons, Matthew-Menacing; Public intoxication controlled subs (excludes alc). Counts 1 & 2: Guilty plea, Set to 30 days in jail, CTS 3 days. Court finds plea is ki&vol.

Dunaway, Holly-Assault 4th degree domestic violence minor injury. Not guilty plea. Def waived days. Bond: \$5,000 surety. Court finds def qualifies & appoints DPA. Pretrial conference: 11-26-2018.

Hubbard, Courtney-Assault-3rd degree-police/probation officer-identi; Disorderly conduct, 1st degree; Menacing; Resisting arrest; Obstructions/Interference with an officer; Hindering prosecution or apprehension-2nd degree. Counts 1-6: Not guilty plea. Def waived days on preliminary hearing. Bond \$5,000 surety. Court finds def qualifies & appoints DPA. Preliminary Hearing: 11-26-2018.

Hubbard, Timothy-Disorderly conduct, 2nd degree; Obstructions/Interference with an officer; Resisting arrest; Hindering prosecution or apprehension-2nd degree. Counts 1-4: Not guilty plea. Bond \$5,000 unsecured. Court finds def qualifies and appoints DPA. Pretrial Conference: 11-26-2018.

Huff, Danielle A-Non payment of court costs, fees or fines. Set to 14 days in jail; CTS 2 days. WOA served 10-28-18 for nonpayment of fine. Court finds insufficient effort to pay fines.

Jackson, Casandra Marie-Improper equipment; Excessive windshield/window tinting; Failure of non-owner operator to maintain req insurance, 1st; Failure to register transfer of motor vehicle. Counts 1-4: Not guilty plea. Court finds def qualifies and appoints DPA. Order for new case # to be assigned by clerk. Preliminary Hearing: 11-05-2018.

Murrell, Pleaz J-Terroristic threatening, 3rd degree; Criminal mischief-2nd degree. Counts 1-2: Not guilty plea. Court finds def qualifies and appoints DPA. Pretrial Conference: 11-05-2018.

Wagers, Noah-Operating on suspended/revoked operators license; Failure of citation for misdemeanor. WOA served for FTA at pre trial conference. Continue to 11-05-2018.

Burkhardt, Dustin K-No/Expired Kentucky registration receipt; No/Expired registration plates; Improper display of registration plates; Failure of owner to maintain required insurance/security 1st-Dismissed without prejudice with proof shown. Counts 1-3: Not guilty plea. Pretrial Conference: 12-10-2018.

Farra, Holly-DUI Counseling. Proof shown.

Feltner, Fredrick J-No/Expired Kentucky registration receipt; No/Expired registration plates; Failure to produce insurance card. Sent court notice. FTA-BW \$100.

Flannery, William T-Operating on suspended/revoked operators license-Guilty plea, \$20 and court costs, 01-07-2019; Failure to wear seat belts-Dismissed without prejudice. Court finds plea is ki&vol.

Flannery, William T-No/Expired registration plates; No/Expired Kentucky registration receipt-Dismissed without prejudice with proof shown with warning; Failure to produce insurance card; Failure of owner to maintain required insurance/security 1st; Operating on suspended/revoked operators license; Improper registration

Counts 5 & 7 & 8: Guilty plea, Set to 3 days in jail, CTS 3 days. Court finds jail time is in lieu of fines. Court finds plea is ki&vol. Order: Bond to be released to postor. Order to correct def's name "William".

Gabbard, Kevin G-TBUT or disp all others u/\$500. Not guilty plea. Bond: \$500 unsecured. Court finds def qualifies and appoints DPA. Pretrial Conference: 11-05-2018.

Gilbert, Shawna D-Speeding 21 mph over limit; Failure to wear seat belts; Failure to produce insurance card; Op mv under/influence of alcohol/drugs, etc. .08 1st off-Guilty plea, Set to 2 days in jail, CTS 2 days, Conc. Counts 1-3 & 5 & 6: Dismissed without prejudice. Court finds plea is ki&vol.

Glaney, William D-No/Expired registration plates; No/Expired Kentucky registration receipt; Failure of owner to maintain required insurance/security 1st; Failure to produce insurance card; Improper registration plate. Counts 1-5: Not guilty plea. Sent court notice. Pretrial Conference: 12-10-2018.

Gray, Vernon Jr-Assault 4th degree domestic violence minor injury; Op mv under/influence of alcohol/drugs, etc. .08 1st off. Brenda Gray recognized to appear. Continue to 11-26-2018.

Green, Brittany J-Failure to wear seat belts; License to be in possession; Operating on suspended/revoked operators license; Rear license not illuminated. Sent court notice. FTA-BW \$250.

Lunsford, Kameron S-Failure to wear seat belts; No/Expired Kentucky registration receipt; Failure of owner to maintain required insurance/security 1st; Failure to produce insurance card; Operate mv u/influ of alc/drugs w/.08, Aggravator, 1st off; Operating on suspended/revoked operators license. Counts 1-4 & 6: Dismissed without prejudice. Count 5: Guilty plea, Set to 30 days in jail, conc., License is suspended with Laurel Co sentences, 60 days & ADE. In Laurel County Jail; JSC to transport from Laurel County Jail to Jackson Co. District Court on 10-29-2018. Court finds plea is ki&vol.
